WHEREAS, The Lumbee Tribe of North Carolina (“Lumbee Tribe”) is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina (“Tribal Constitution”) and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina (“Tribal Council”), and;

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina has an Education, Cultural, and Public Relations Committee; and,

WHEREAS, This committee has established a Lumbee Tribal Educational Scholarship to assist tribal members through scholarships in their efforts to assist in the finances of their education, and;


WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina will name the top three scholarships the Kernice Lee Locklear Scholarship in the amount \$1000, and;

WHEREAS, The Education, Cultural, and Public Relations Committee of the Tribal Council will establish a committee each year to oversee the process of weighing and grading applications for dispersing funds to applicants, and;

THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby support the naming of the top three scholarships of the Lumbee Tribal Educational Scholarship award the Kernice Lee Locklear Scholarship and in the amount of \$1000 each.
