IHBG CARES Budget

WHEREAS, The Lumbee Tribe of North Carolina, a recognized Indian Tribe of the State of North Carolina subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and

WHEREAS, Article VII Section 1-b of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

WHEREAS, The Tribal Council has the authority to approve, enact and amend the annual fiscal year budget and budget process; and

WHEREAS, The Tribal Council is responsible for oversight and review of all budget components; and

WHEREAS, The Tribal Council has authority and fiduciary responsibility to ensure compliance with program funding and allocations; and

WHEREAS, The Lumbee Tribal Budget "IHBG CARES Budget" is addressed with the provisions as stated below, and

THEREFORE, The Lumbee Tribal Budget "IHBG CARES Budget" is to prepare, prevent, and respond to COVID-19, and

THEREFORE, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance shall be cited as "IHBG CARES Budget", subject to all inclusions and provisions.




Provisions:

1. General Supplies
 - PPE – 8,000 households at \$50 each
 - Educational Materials – 4,000 participants at \$50 each
 - Cleaning Supplies – 500 participants at \$50 each
 - Food Boxes – 4,000 participants at \$50
 - Testing kits – 2,000 participants at \$125 each utilizing a voucher system with local Native American Indian Physicians
2. Disaster/Pandemic Services
 - Mortgage/Rental/Utilities – 4,599 households up to \$700 each




