**WHEREAS**, The Lumbee Tribe of North Carolina (“Lumbee Tribe”) is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina (“Tribal Constitution”) and its inherent powers and self-government, and;

**WHEREAS**, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina (“Tribal Council”), and;


**WHEREAS**, The Constitution of the Lumbee Tribe of North Carolina authorizes the Tribal Chairman & Tribal Council to make nominations and confirm the nominees to the Election Board of the Lumbee Tribe of North Carolina, and;

**WHEREAS**, Sharon Oxendine was nominated for District 2 (Tribal Council District 6, 8 and 9), as an board member to serve on the Election Board of the Lumbee Tribe of North Carolina, and;

**THEREFORE**, be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby support the nomination of Sharon Oxendine to the Election Board of the Lumbee Tribe of North Carolina.
