**WHEREAS**, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

**WHEREAS**, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council, and;

**WHEREAS**, Traditionally, the Lumbee people have sustained themselves through the passing down of agrarian customs and techniques from our elders to our youth, and;

**WHEREAS**, The Lumbee Tribal Constitution charges the Tribal Council with the authority and responsibility to preserve for all time the Lumbee way of life and community, and;




