**WHEREAS**, The Lumbee Tribe of North Carolina a recognized Tribe of the State of North Carolina Subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and

**WHEREAS**, Article VII, Section 1 of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

**WHEREAS**, Tribal Council has the authority and fiduciary responsibility to ensure compliance with all programs funding and allocation; and

**WHEREAS**, The Lumbee River, surrounding lands and natural resources are vital to the sustainability of the Lumbee people; and

**WHEREAS**, The Lumbee Tribal Council has the authority and responsibility to protect the quality of life of the Lumbee people; and

**THEREFORE**, Be it resolved the Lumbee Tribal Council does hereby duly establish the Agriculture/Natural Resources Subcommittee and this legislation shall be cited as **“Agriculture/Natural Resources Subcommittee”**.


