**REPEAL OF ORDINANCES: CLLO-2005-003 "GENERAL ORDINANCES GOVERNING THE DUTIES OF THE TRIBAL COUNCIL OFFICERS AND DECORUM OF COUNCIL MEETINGS." CLLO-2007-0719-01 "ORIENTATION OF NEW TRIBAL COUNCIL REPRESENTATIVES." CLLO-2006-0720-01 "GENERAL ORDINANCE ON CONTENT AND FORM OF ORDINANCE AND RESOLUTIONS"**

**WHEREAS**, The Lumbee Tribe of North Carolina, a recognized Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government;

**WHEREAS**, Article VII, Section 1-b of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

**WHEREAS**, In accordance with Article VII, Section 1-b of the Constitution of the Lumbee Tribe, the Tribal Council shall adopt rules and regulations governing the Council's procedure and decorum of its legislative branch; and

**WHEREAS**, The Tribal Council of the Lumbee Tribe of North Carolina adopted Tribal Council Rules and Regulations TCRR-2012-0119-01 "STANDING RULES OF ORDER AND REGULATIONS GOVERNING THE ORIENTATION OF NEW TRIBAL REPRESENTATIVES, TCRR-2012-0119-02 "STANDING RULES OF ORDER AND REGULATIONS GOVERNING THE PREAMBLE TO THE LUMBEE CONSTITUTION", TCRR-2012-0216-02 "STANDING RULES OF ORDER AND REGULATIONS GOVERNING THE CONTENT AND FORM OF ORDINANCES AND RESOLUTIONS .

**THEREFORE**, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina hereby **REPEALS ORDINANCES: CLLO-2005-003 "GENERAL ORDINANCES GOVERNING THE DUTIES OF THE TRIBAL COUNCIL OFFICERS AND DECORUM OF COUNCIL MEETINGS." CLLO-2007-0719-01 "ORIENTATION OF NEW TRIBAL COUNCIL REPRESENTATIVES." CLLO-2006-0720-01 "GENERAL ORDINANCE ON CONTENT AND FORM OF ORDINANCE AND RESOLUTIONS"** as they duplicate action taken in Tribal Council Rules and Regulations TCRR-2012-0119-01 "STANDING RULES OF ORDER AND REGULATIONS GOVERNING THE ORIENTATION OF NEW TRIBAL REPRESENTATIVES, TCRR-2012-0119-02 "STANDING RULES OF ORDER AND REGULATIONS GOVERNING THE PREAMBLE TO THE LUMBEE CONSTITUTION", TCRR-2012-0216-02 "STANDING RULES OF ORDER AND REGULATIONS GOVERNING THE CONTENT AND FORM OF ORDINANCES AND RESOLUTIONS . taken by the Tribal Council of the Lumbee Tribe of North Carolina.
