## **“PEMBROKE BG CLUB/COMMUNITY CENTER (ELDERS AREA) ORDINANCE”**

*WHEREAS*, The Lumbee Tribe of North Carolina, a recognized Indian Tribe of the State of North Carolina subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and

*WHEREAS*, Article VII, Section 1 of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

*WHEREAS*, The Tribal Council has the authority and fiduciary responsibility to ensure compliance with all program funding and allocation; and

*WHEREAS*, The Lumbee Tribe of North Carolina operates the Housing Program under NAHASDA grant in an effort to better the living conditions of its tribal members; and

*WHEREAS*, The Tribal Council appropriates funds for district Boys/Girls Club and Community Centers; and

*WHEREAS*, In a collaborative effort Districts 6, 7, 8 Tribal Council representatives and tribal members resolved to merged the tri-district boys/girls club and tribal elders council; and

*WHEREAS*, In resolution CLLR-2011-0120-01 “PEMBROKE COMMUNITY CENTER (ELDERS)” the elders area was amended from 634 sq. ft to 1274 sq. ft by the elimination of offices, in order to provide adequate space for elder activity; and

*WHEREAS*, Tribal administration has knowingly failed to comply with CLLR-2011-0120-01.

*THEREFORE*, Be it enacted by, the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance that shall be cited as, **“THE PEMBROKE BG CLUB/COMMUNITY CENTER (ELDERS AREA).”**

*THEREFORE*, Be it further enacted the elders area shall be amended from 634 sq. ft. to 1274 sq. ft. and the Pembroke Elders Heritage Group shall utilize the newly constructed office spaces adjacent to the Elders Area.

**SECTION 1: DEFINITION**

(a) The term "resolution" means the official expression of the opinion or will of a legislative body, when adopted; it becomes the official position of the legislative body.

**SECTION 2: SEVERABILITY**

The provisions of this act are severable and if any part or provision hereof shall be held void, the decision of the court so holding shall not affect or impair any of the remaining parts or provisions of this act.
